

About SDX Foundation

The S.LIFE Foundation, which has strived to create a better future since its establishment in 2015, changed its name to the 'SDX Foundation' in March 2021 and was newly launched as an institute which pursues sustainable development (SD) based on digital transformation (DX). The SDX Foundation has launched the SDX Carbon Reduction Committee in June 2022 to operate the Voluntary Carbon Neutrality System (VCNS) and has endeavored to build a voluntary carbon market through climate performance certification (GCR) and carbon reduction certification (CRC).

From June 2022, we have held the 'Private-led Carbon Reduction Forum' every other month, and renamed to 'ReWorld Forum' by expanding and reorganizing it into a forum that overcomes the climate crisis and seeks a new order for future. We successfully held the first forum on April 26, 2023. In addition, we have launched the Education Research Institute (SERA), which provides carbon reduction and ESG-related education such as ISO 5001 certification audit training.



The Carbon Reduction Committee is a civilian committee organized by the SDX Foundation to encourage private sector participation in voluntary carbon reduction, actively develop and implement a roadmap for carbon reduction action, and scale it up to citizens, businesses, local governments, and the globe.

1. Establish and promote a joint public-private response system for the Global Green New Deal and carbon neutrality.

2. Contribute to achieving the 2050 carbon neutrality goal and building a stable implementation system.

3. Strengthen the support and cooperation system for low-carbon and eco-friendly innovative technologies and enterprises.

4. Discover and promote virtuous cycle infrastructure for environment (carbon neutrality) and growth (new industry) ecosystems.

5. Enhance domestic and international cooperation systems and participatory implementation systems of experts, enterprises, and NGOs.

"Evaluate & Certify Carbon Reduction"

Promote carbon reduction certification and climate technology certification projects that evaluate carbon reduction amount of climate technology companies based on life cycle assessment (LCA).

"Evaluate & Proliferate Climate Action"

GCM

Promote diffusion projects through building ecosystems for granting climate performance certification (GCR) ratings to Green Class Members (GCMs), climate technology companies and for accelerating GCMs' climate action

"Provide Integrated Carbon Reduction Plan in a large scale"

GCS

Perform Carbon reduction plan and consulting through diagnosing carbon reduction technology and developing indicators for GCM (Green Class Member) companies

ECR

"Operate Carbon Financing System"

Energy & Carbon Reduction (ECR) provides energy solutions that integrate finance and technology to support the carbon reduction activities of energy users such as public entities, businesses
